There was a bedbug scare at Redwood. The incidence was handled well. A bite was observed on a student and one bedbug was found. The rooms and busses were treated where the student was. They had been discovered about a week ago, and the replacement of mattresses and treatments were completed within days.

Before Christmas Avon's mayor called regarding the drug problem and what we can do. Avon has done very little with addiction and drug use. We have had two meetings as a group with Cleveland Clinic as a resource. A joint newsletter will be sent to each household going forward. Cleveland Clinic would like to come into the schools and work with the kids, especially the high school students. Our kids don't necessarily respond to parents and schools, but they do respond to professionals. Trainers are already working with both cities. Educating families on getting rid of prescription painkillers is important. We are working on putting a plan in place, so each group/grade of kids have a permanent guideline. They are currently doing presentations with individual classes. We require students that have been caught must meet five times with the LCADA counselors. They are also at the library Thursday afternoons. The program at the library is confidential and is utilized by students and parents alike. Students may go to counseling during study halls.

The IBM Watson program presentation is moving slowly. Our pilot group (which is 5th and 6th-grade language arts) will not happen until at least August of next school year. Natalie Fior has gone to observe the

program twice. Those schools have changed their needs, and as a result, the program is moving slower than expected. It is a three to a five-year pilot program. The program will follow these students through high school. Once a child goes into the system, it will be the central place for information on a particular child. Teachers will be able to go back and see a child's education path.

NRG update: they will remain open for the foreseeable future. The battle with the school district continues, and we have repealed with the Supreme Court. The county is valuing NRG next year at 80m. NRG wants valuing to be at 18M. Our concern is that when the value drops we lose revenue. The library would have to pay back \$42,000.

We are looking at redoing the media center at the high school. We did an audit, and we have 13,000 books in the library of which 10,000 books have not been checked out. The book section is being looked at a redesign to be used as a teacher center and utilized as a teaching area. Books will not be done away. The books that are not being used are being looked at to possibly sell. There may also be a digital library, which is already being utilized.

Legislation for state funding is ongoing. School districts receive money back for tangible personal property. State Legislature personal tangible property was considered a bad tax. The local revenue needs to be replaced. School districts like Berea receive 10m and would lose that money. They would have to put up a levy for 8M. Fair Funding, there are 80 schools, including parochial schools, receive funding. The State gives us \$900 per student. Kasich vetoed, and we are trying to reclaim.

SWOT is going well. The principle's meeting is this afternoon, and the piece for the community should be finalized. Some changes should be expected for next school year. SWOT will be revisited every few years.

Consumer Sciences should be brought back (spoken about by Krissy Hart). Every student would benefit from this class. Keyboarding and, Communications are being looked at to add next year. More classes should be offered for students that are middle road and that each student can take as opposed to honors or AP classes.

The Code Red glitch has been fixed. We had tested it, and it worked at that time. When it came time to use Code Red they had not connected Avon Lake.
